Role Responsibilities

- Carry out duties in accordance with Territory Generation's safety, environmental and quality policies, safety principles, corporate values and strategies.
- 2) Actively model Territory Generations values in order to drive a constructive culture.
- 3) Conduct on-the-ground operations work, including routine plant inspections, equipment isolations, equipment lubrication, routine tests, identification, investigation and where possible rectification of plant defects.
- 4) Maintenance shutdown and plant condition reporting.
- 5) Perform routine and shutdown maintenance works including housekeeping.
- 6) Identify and attempt to diagnose abnormal operation of equipment and/or refer to suitable expertise.
- 7) Direct, undertake or supervise work as necessary to maintain the safety of personnel on the site and to ensure the safe, reliable and efficient operation of the power station plant.
- 8) Carry out the training, mentoring and assessment of new OMT employees.
- 9) Carry out learning and on the job training through the OMT career path to enable relief of and eventual potential position of the plant in the 24/7 OMT role.
