Role Responsibilities

Based permanently at Owen Springs Power Station (OSPS), the Operator will work shift work as required to achieve effective monitoring of generating plant and associated equipment across the differing technologies at the OSPS.

Key accountabilities include:

1. Work with the Remote Operations Centre (ROC) in Berrimah to achieve safe and efficient operations of the power station. Operate part (or all) of the power station in local mode when directed by the ROC.
2. In conjunction with the Southern Regional Operations Manager, coordinate the Safe Systems of Work (SSoW) systems and processes to deliver safe access to plant for planned and unplanned maintenance.
3. Conduct operations routines and work on the power station, including (but not limited to) routine plant inspections including gas turbines, reciprocating engines and associated plant, including water treatment plant, equipment lubrication, routine tests, identification of plant defects through the business ERP (Pronto).
4. Track all of your work hours through associated work orders in the business ERP (Pronto).
5. Participate in 24/7 shift roster
6. Direct, undertake or supervise work as necessary to maintain the safety of personnel on the site and to ensure the safe, reliable and efficient operation of the power station plant.
7. Carry out duties in accordance with Territory Generation's safety, environmental and quality policy, safety principles, corporate values and strategies.

Selection Criteria

Essential

1. Demonstrated competence in the area of workplace safety and commitment to safe work practices.
2. AQF Level III Certificate or relevant skills, knowledge and experience
3. Demonstrated understanding and proven experience in contributing to the achievement of a constructive culture.
4. Demonstrated interpersonal and communication skills which have resulted in effective team membership and contribution to workplace objectives.
5. Proven ability to analyse technical systems and assess /report anomalies.
6. Well-developed computer literacy.
7. Experience with continuous shift work.

Desirable

1. Experience in the operation of gas turbines, dual fuel and spark fired reciprocating engines (Man Diesel 51/60DF and GE J624 Jenbacher's) and exposure to defect reporting ensuring that information and accuracy of defect is of a high standard.
2. AQF Level III Certificate in a Mechanical/Electrical Trade
3. Trade related experience within the power supply industry.
4. Experience within a Permit to Work system that ensures safety access to plant.
